# **INSTRUCTIONS TO APPLICANTS**

- Before applying for the Duplicate Degree Certificate, the candidate should have explored all the possibilities of retracing the Original Degree Certificate and, only if she / he is convinced that the Original Degree Certificate has been lost irrecoverably, she / he can apply for the same
  - Incomplete applications will be rejected. No correspondence will be made on this matter.
- The filled in, completed application form and supporting documents must be submitted by hand or sent by post to **the Director of the SSSIHL Campus where she/he studied**.

For contact information, visit the Contact Us page of the SSSIHL website.

In the event of loss in transit / misplacement of the Original Degree Certificate, a police complaint has to be lodged and an acknowledgement obtained from the police station. The copy of the complaint and the original acknowledgement must be enclosed along with the application. (*Reference*: *Item 8*)

A press notification as per the format (given below) has to be published in a daily and the newspaper cutting has to be enclosed along with the application. (*Reference*: *Item 9*)

An affidavit, sworn before a Notary / First-class Magistrate must be enclosed as per the format (given below). (Reference: Item 10)

- a) Applicants are required to send a self-addressed, cloth-lined envelope 16x12 inches in size along with the application. The Institute requires this in order to send the Duplicate Grade Card back to the applicant by post.
- The name of the applicant, along with the full, complete postal address, including the town/city, PIN code, district and state must be clearly written or typed on the envelope.
  - Stamps totalling ₹55 must be affixed on the top right-hand corner of the envelope. This will ensure safe delivery of the document by India Post, via Registered Post with Acknowledgement Due.

    Students of foreign nationality may affix appropriate postage for an envelope weighing 100-120 g.
